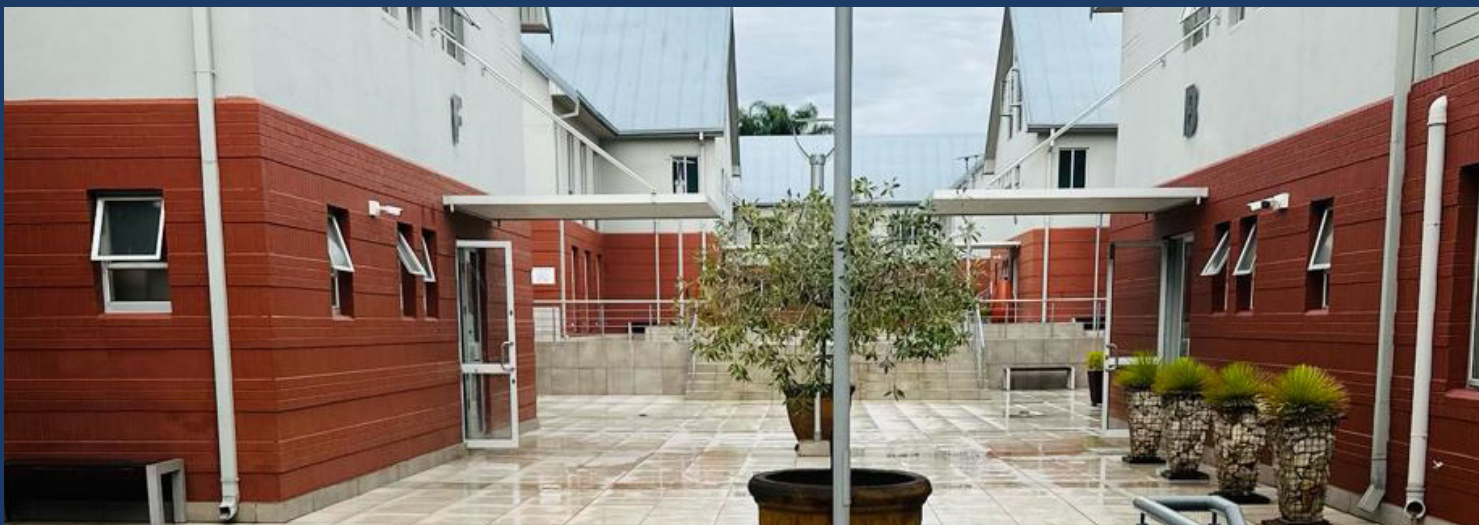
SELLO MAHLO

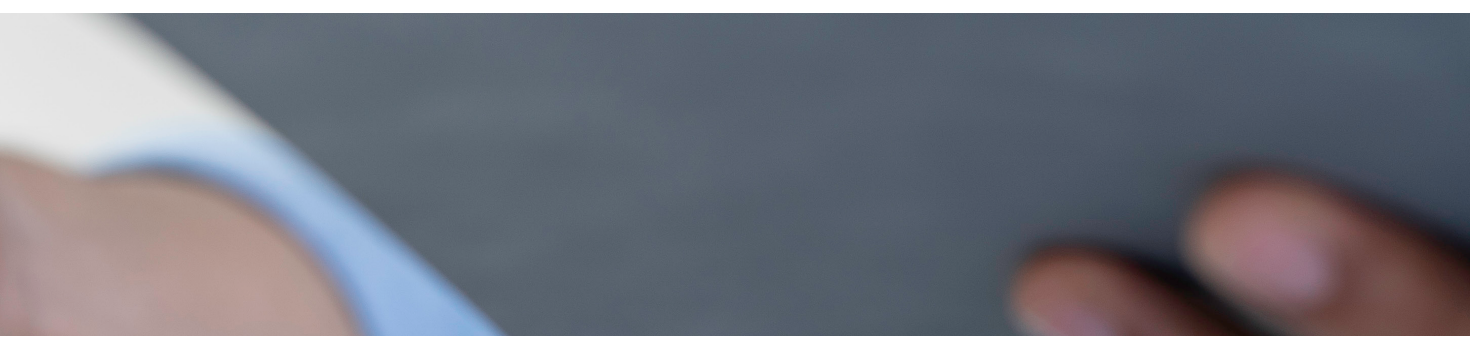
